WHAT A WINNING STREAK!

Livv Housing (Knowsley) - members accepted an improved pay offer of 8.5% - 10% employer pension contributions & 3 days annual leave after 150 days strike action

Mitie East Lancashire Domestics & Supervisors - covid "bonus" payment paid after 10 days strike action

GMMH Early Intervention Service - millions of pounds additional funding secured after 23 days strike

East Lancashire HCAs - HCAs recognised as Band 3 undertaking clinical duties with back pay to April 2018.

Cumbria & North Lancs HCAs - HCAs recognised as Band 3 with back pay to April 2018 before strike.

Blackpool HCAs - HCAs recognised as Band 3 with back pay to April 2018 after 2 days strike action

Mersey Care Phlebotomists - all Phlebotomists (including bank staff) accepted 8.72% pay increase and an average back pay deal before any strike action.

Transport for Greater Manchester - improved offer following 20+ days strike action

Manchester Airport - members accepted improved offer following successful consultative industrial action ballot

Cheshire PCSOs - plans to cut up to 70% of jobs scrapped

Northern Care Alliance Plaster Technicians - members accepted improved offer following industrial action mandate

Migrant Workers - After months of campaigning, NHS sponsorship threshold stays the same to allow Band 3 HCAs to get sponsorship following new pay rise.

For Futures For Housing - a withheld April 2025 pay rise implemented before TUPE'd back into Cheshire West Council.

Lancashire Care Homes - Reform council forced to U-turn following industrial action threat, march of staff, resident's families and the local community.

North West Probation - members accepted improved offer following industrial action mandate.
